III. Treasurer's Report - Kristy Rachkowski

- Born & raised in Algoma. I grew up in Echo Bay and my first introduction to Searchmont was through a school program that brought us out to the hill when I was in grade 6 and I have been skiing ever since.
- I moved away for University and over the past 16 years have lived in Ottawa, Kingston, Thunder Bay, Toronto, Halifax then back to Vaughan and now finally, my husband and I are settling in Echo Bay.
- In the last year My husband and I decided we wanted to move back to the Northern Ontario to be closer to family where we have deep roots in this city
- My educational background is varied, I studied Criminology & Psychology at the University of Ottawa and earned my undergrad from there
- I am currently 95% of the way through completing my Masters in Business Administration and if all goes as planned I will graduate from Dalhousie University this fall
- I am also a certified Yoga instructor and have been teaching part time since 2009 and I am a certified hypnotherapist so you should be very nervous
- My professional experience consists of working most of my career at TD Bank where I started out in Customer Service, transitioned into Financial Advising roles and then into Management positions before making a switch and moving into Human Resources where I spent 7 years and eventually became an executive in 2010.
- I transitioned back into the business for 2 years as a district vice president in the Muskoka & Kawartha Lakes areas.
- I was then asked to take on the Vice President of HR role supporting the retail banking network in Canada

- and that was the role I have held since early 2013 up until taking a leave this year and moving back.
- 2016 is the first year in the last 7 that we have completed a full audit and we partnered with KPMG this year to complete that process and those audited statements are available on the Searchmont website.
- We want to continue to complete full audits annually but feel it is prudent as an organization to develop a longerterm relationship with an accounting firm, therefore we are going to be going to RFP for a 3 year term in the next few months.
- For the past 9 Years SSAI has access to a \$100K LOC with RBC that is guaranteed by the EDC in order to finance operations during the off season.
- That LOC comes up for renewal every 3 years and we are due to present to Council in December to request a renewal.
- Finances at the hill are and have always been tight so we rely on this LOC to keep the hill going.
- We anticipate Council agreeing to the extension for another 3 years given - we will know the decision at the December 12th meeting.
- We have seen a nice flow of pass sales coming in and the announcement about opening the quad has helped as has this recent dusting of snow.
- We anticipate a healthy year at the hill and expect to be open for 70+ days this
- We do have however a focus on continuous fundraising efforts in order to help us meet our financial targets this year. The Development committee will be instrumental in identifying and executing events & activities to help the hill hit its goals.
- thank you also to Justus Veldman & Riversedge
 Developments for their ongoing financial support of the
 hill. He has made several very generous donations to
 SSAI throughout the past year and last season to
 ensure this community asset stayed in operation
- Thank you to partners at EDC who have generously assisted the hill with financing needs to open the quad, complete repairs and ensure that we have the proper equipment to be effective.
